Games start at 8:00am at Stevens High School in Rapid City, SD

Cost: \$100 (Please make checks payable to Black Hills Juniors)

Ages 12, 13, 14, 15, 16, 17/18 (Teams do not have to be sanctioned i.e. AAU, JVA, USAV)

- Each team will play 3 pool play matches followed by a single elimination tournament for each division.
- Pool play is 2 sets to 25, cap at 27 (no third set). Tournament play is best 2 out of 3 to 25, third set to 15 if needed (no cap on tourney games). We will have a rolling schedule so please keep matches going on each court.
- Warm up for 1st games are 2-2-2, after that there will be 2 minutes of shared court.
- Division champions will receive a medal.
- Officials are NOT provided. Each team will be responsible for up and down referees, 2 line judges, a score keeper, and a score flipper. Teams must provide their own whistle. NO CELL PHONES while completing your officiating responsibilities.
- Entry fee for spectators is \$3.00 per person (12 and under are free).
- Concessions will be provided. (Please dispose of your trash and ensure your team is cleaning up after themselves.)
